The Citizens Advisory Committee of the NY-NJ Harbor Estuary Program (HEP CAC) hereby resolves to express its opposition to the New Jersey Department of Environmental Protection's recently announced policy banning oyster restoration research and oyster gardening projects in waters closed to shellfishing. HEP CAC recognizes that oyster restoration is a key component of overall environmental restoration in the New York-New Jersey Harbor Estuary, that oysters are a keystone species that perform numerous and invaluable ecological functions and, through their prodigious ability to filter pollutants from the water, represent an opportunity to improve water quality and enhance ecosystem health that should not be missed. Further, oyster gardening and research present valuable educational opportunities and serve the public's inalienable right to access its public trust waters. We believe that any threat to human health is minimal, and is best addressed by already in place security features in existing and planned research and gardening projects and improved on-site security rather than an outright ban.
